- All property stored on the premises shall be at lessee's sole risk. Lessee understands and acknowledges by signing this agreement that MCFA shall not, does not and will not carry insurance of any kind for the Lessee's item(s) stored. In addition MCFA shall not be held liable to Lessee for any damage to, or loss of, any personal property stored during the term of this Agreement. MCFA shall not be responsible for theft or damage to any of the Lessee's property and Lessee expressly waives and releases MCFA from any such claims. Lessee shall indemnify, hold harmless and defend MCFA from all claims, demands, actions or causes of action (including attorney fees and all costs) that are brought by any party arising out of Lessee's use of the storage space at the Monroe County Fairgrounds in Bloomington, Indiana.
- All antennas must be either folded down or removed prior to check in for storage. The maximum height of any item(s) stored is 13' 6".
