# *Welcome to the 2023 Monroe County Fair!*

Our theme for 2023 is, “We’ve Got It All at the County Fair”. The Monroe County Fair is a highlight each summer for this community. Young people in 4-H work on their projects and raise their animals in order to show them at the fair. Extension Homemakers and adults worked to put projects in the Open Class buildings. Businesses within the county, share their information in the commercial building, and there is always fun and excitement with our carnival, derbies and music performances and activities on the grounds. The Monroe County Fairboard works diligently throughout the year to make sure there is something at the fair for everyone. So please take time to see all that the fair has to offer.

## *A little history....*

Fairs have been a part of Monroe County’s history since its earliest days. The first Agricultural Society was organized in 1835; but it is not known if they held a fair. The first annual county fair of the Monroe County Agricultural Society was held in 1855. It was not the first fair; however, it apparently was the first one to be established on an annual basis. These fairs were discontinued during the Civil War, then renewed in 1868 on the land now known as Dunn Meadow on the campus of Indiana University. From early 1880’s until 1946, fairs were held in various locations around the county. In 1946, the Bloomington Chamber of Commerce began their ten-year sponsorship of the Monroe County 4-H Clubs by providing a site for the fair and funds for premiums. The fair then was held in the Indiana University field house, located on East 7th Street. The Monroe County Fair Association was organized in 1955 and the fair has been held annually at the present site since that time. In 1986, and additional 51+ acres of land was purchased adjacent to present fairgrounds to allow for expansion.

## *In gratitude....*

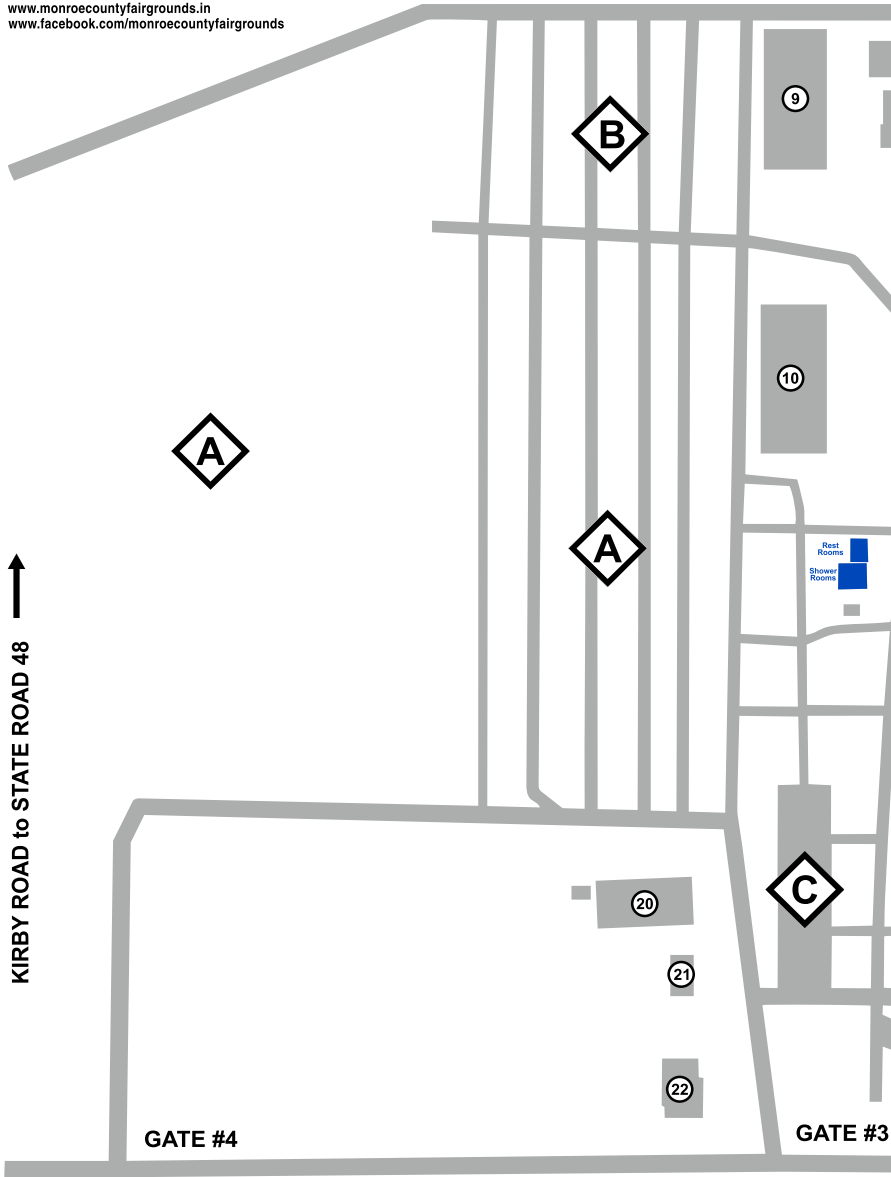

Today these improvements are made through donations, advertising, rentals of buildings, and the public’s attendance at the events on the fairgrounds. The permanent structures, premiums, and operation expense of each year’s fair are visible confirmation of the ongoing efforts of the Monroe County Fairboard.

We are very proud of the continued growth of the fair. It takes a lot of interested people working many hours to put on the fair each year. The Monroe County Fairboard works alongside many community groups to achieve this accomplishment. The board recognizes and appreciates all groups and individuals who offer their time and talents. It is with sincere gratitude that we thank all who help and support in any way.

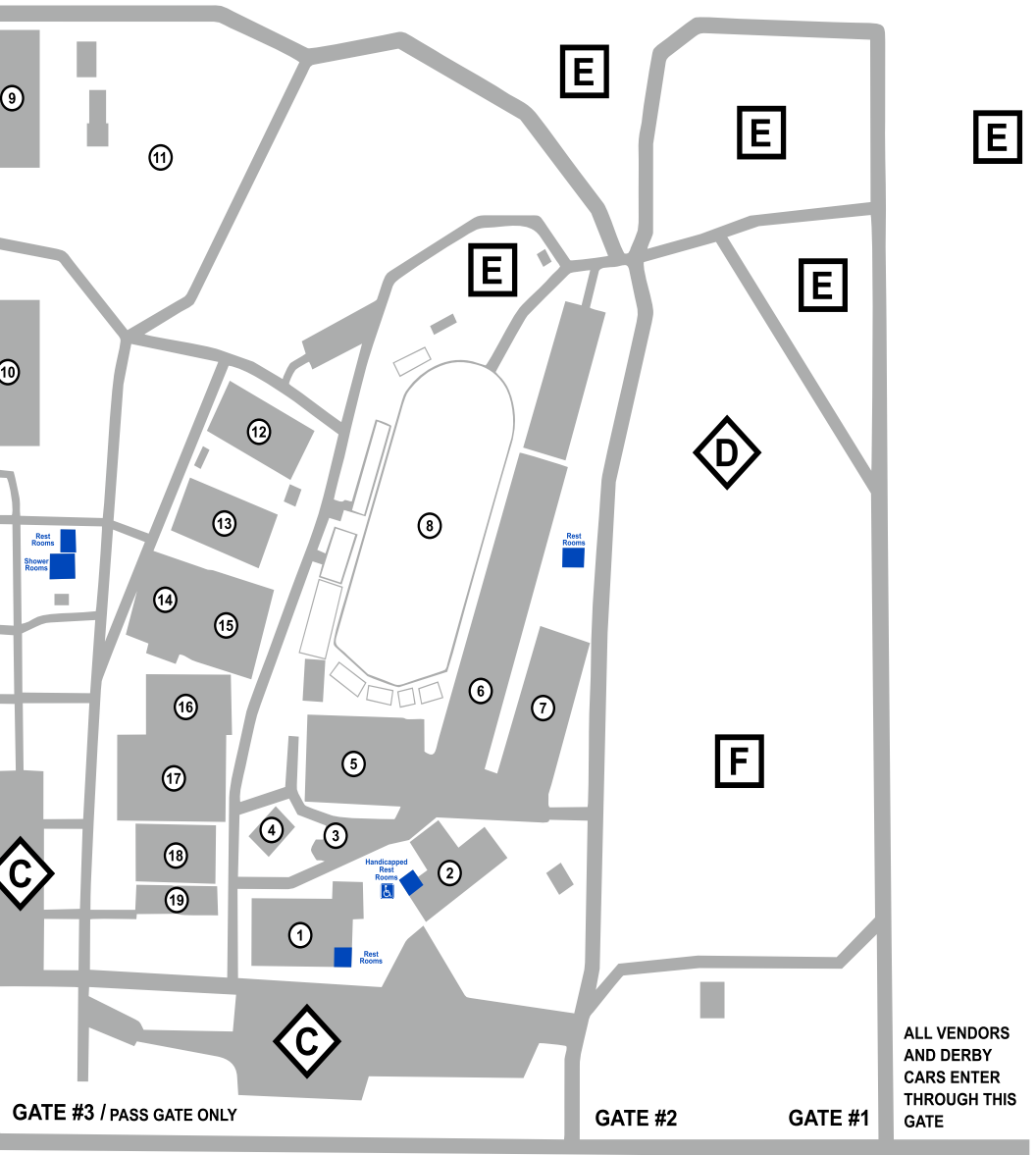

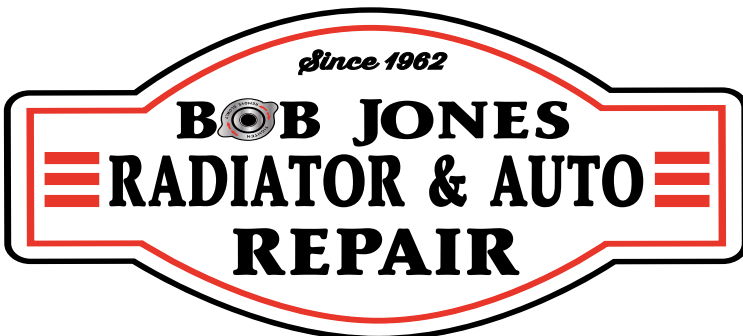

# ANIMAL HEALTH REQUIREMENTS FOR EXHIBITION OF DOMESTIC ANIMALS IN INDIANA 2023

This document describes the Indiana State Board of Animal Health's (BOAH) requirements for all animal exhibitions in the state. However, exhibition organizers may impose additional requirements as a condition of exhibition. **BOAH recommends contacting the exhibition organizer for specific information about requirements for each event.**

Please call the Indiana State Board of Animal at (317) 544-2400 with questions concerning exhibition requirements in Indiana.

## GENERAL REQUIREMENTS FOR ALL SPECIES

### **A. Limitations on Exhibition**

This section describes limitations on exhibiting animals in Indiana. Other exhibition limitations may be described in the species-specific requirements that follow.

1. Failure to meet all animal health requirements will result in removal of animals from the exhibition premises.
2. The following animals are not eligible for exhibition in Indiana:
  - a. Animals that originate from a herd that is under quarantine.
  - b. An animal prohibited from exhibition under any law or order.
  - c. Any animal classified as a brucellosis "suspect".
  - d. Animals showing signs of any infectious or communicable disease or that are a health hazard to people or other animals.
  - e. Any animal that does not meet state animal health requirements.
3. Any animal that develops or shows signs of any infectious or communicable disease during exhibition must be removed from the premises, including the surrounding exhibition grounds. An owner who is disputing the exclusion of his/her animal(s) from exhibition may not exhibit the animal in question pending any appeal.
4. The State Veterinarian is authorized to make the final determination as to an animal's eligibility for exhibition. The state veterinarian may order removal of any animal from the exhibition grounds.
5. Exhibition organizers may impose health requirements in addition to those prescribed by BOAH. Added requirements may not contradict requirements imposed by BOAH.
6. Exhibition organizers may have a licensed and accredited veterinarian review animals and animal health documentation during the exhibition.



## GENERAL REQUIREMENTS FOR ALL SPECIES



### B. Certificates of Veterinary Inspection

1. **For animals located within Indiana**, a certificate of veterinary inspection (commonly known as a “health paper”) is not required by BOAH for exhibition. Contact the exhibition organizer to determine if a certificate of veterinary inspection (CVI) is necessary to meet the organizers exhibition requirements.
2. **For animals located outside of Indiana**, the exhibitor must have a properly completed CVI for all animals prior to entry. This requirement applies to all domestic animals (except fish and poultry).
  - a. CVIs must be completed by a licensed and accredited veterinarian who has personally inspected the animals.
  - b. A CVI for any animal is valid for 30 days from the date it is issued by a licensed and accredited veterinarian. *NOTE: Animal(s) must be inspected by a licensed and accredited veterinarian no more than ten days prior to the date in which the CVI is issued.*
  - c. CVIs must clearly include a description of each animal including the age, sex, and breed of the animal, and the official individual identification.
  - d. CVIs must accompany the animal while on the exhibition premises.
    - i. CVIs can be made available in their original format (i.e., digital, or physical copy)

### C. Pre-Entry Movement Permit

1. **For swine and cattle located within of Indiana**, a pre-entry movement permit is not required.
2. **For swine and cattle located outside of Indiana**, a pre-entry movement permit is **not required** when an **electronic** certificate of veterinary inspection is issued.
3. **For swine and cattle located outside of Indiana**, a pre-entry movement permit **is required** when a **paper** certificate of veterinary inspection is issued.
  - a. The 2023 Indiana State Fair pre-entry movement permit number is “**INSF23**” and must be noted on all **paper** certificates of veterinary inspection.
4. **For farm raised cervids located outside of Indiana**, a BOAH approved pre-entry movement permit number must be noted on the certificate of veterinary inspection. Permit applications are available online at: [www.in.gov/boah/species-information/cervids-deer-elk/](http://www.in.gov/boah/species-information/cervids-deer-elk/)
  - a. The pre-entry movement permit application must be received by BOAH at least 5 business days before moving into Indiana.



## GENERAL REQUIREMENTS FOR ALL SPECIES

- b. The Indiana State Board of Animal Health must authorize any proposed movements **prior** to entry into the State.

### **D. Indiana State Fairgrounds**

1. The Federal Premises Identification Number for the Indiana State Fairgrounds that should be recorded on all associated CVIs is: **00C6T69**
2. The physical address for the Indiana State Fairgrounds that should be recorded on all associated CVIs is: **1202 E 38<sup>th</sup> St, Indianapolis, IN 46205**

### **E. Identification**

All exhibition animals must be permanently and individually identified unless otherwise noted. Official ear tags are tags approved by the USDA that bear the US shield. All official identification and any additional identification devices should be recorded on the certificate of veterinary inspection.

### **F. Testing**

1. All tests required for exhibition must be conducted at the Animal Disease Diagnostic Laboratory (ADDL) at Purdue University, a laboratory approved by the Indiana State Board of Animal Health, or a state or federal-approved laboratory.
2. All animals, including Indiana animals, that are to be offered for sale to out of state buyers should have the necessary testing completed prior to the sale date. The destination state should be contacted to ensure all pre-entry movement requirements are met prior to the planned movement. 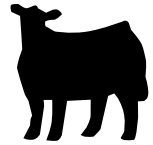

### A. Cattle

#### 1. SEE GENERAL REQUIREMENTS FOR ALL SPECIES

#### 2. Identification (**ONE** of the following)

- a. 840 tags
  - May or may not be an RFID (radio frequency device)
  - 15 digits, beginning with "840," with US shield
- b. NUES (brite) tags
  - National Uniform Ear Tagging System
  - Steel or plastic acceptable, with US shield
- c. Official USDA Program tags
  - Orange calfhood vaccination tags, with US shield

#### 3. Testing

- a. **Cattle located within Indiana** do not need a brucellosis test or a tuberculosis test for exhibition in Indiana.
- b. **Cattle located outside of Indiana** do not need a brucellosis test or a tuberculosis test for exhibition in Indiana as long as the state of origin is classified as brucellosis free **AND** tuberculosis free by the USDA.
  - Cattle from states that are NOT designated as free by the USDA must meet additional requirements for entry into Indiana. Contact the Indiana State Board of Animal Health for specific information.



## B. Swine

#### 1. SEE GENERAL REQUIREMENTS FOR ALL SPECIES

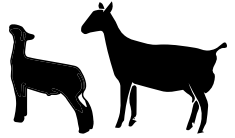
#### 2. Identification (**ONE** of the following)

- a. 840 tags
  - May or may not be an RFID (radio frequency device)
  - 15 digits, beginning with "840," with US shield
- b. NUES (brite) tags
  - National Uniform Ear Tagging System
  - Steel or plastic acceptable, with US shield
- c. Official Premises ID Number ("PIN") tag
  - Official PIN tags **MUST** include a premises number and unique animal ID imprinted by the manufacturer. (Standard PIN tags usually do not include an individual ID number; therefore, owners need to specify when ordering.)
- d. Ear notch
  - Ear notch must be recorded in the book of record of a purebred registry association.
- e. Tattoo
  - Tattoo must be registered with a swine registry association.

#### 3. Testing

- a. **Swine located within Indiana** do not need a brucellosis test or a pseudorabies test for exhibition in Indiana.
- b. **Swine located outside of Indiana** do not need a brucellosis test or pseudorabies test as long as the state of origin is classified as brucellosis **AND** pseudorabies free by the USDA.

### C. Sheep and Goats

#### 1. SEE GENERAL REQUIREMENTS FOR ALL SPECIES

#### 2. Identification (**ONE** of the following)

- a. Official Scrapie identification tag, with US shield
- b. Official Scrapie tattoo
  - Must begin with the state postal code along with a unique individual animal ID number
- c. Registration tattoo
  - Tattoo must be noted on the registration paper and accompany the animal
- d. Registration microchip
  - Electronic implant must be noted on the registration paper and accompany the animal

*NOTE: Wethers younger than 18 months of age must bear a unique and permanent form of identification*

#### 3. Testing - No testing is required on any sheep or goat for exhibition in Indiana.

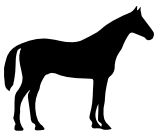

### D. Horses

*NOTE: Indiana State 4-H may impose vaccination requirements for horse show participants beyond the minimum requirements of the Indiana State Board of Animal Health. Contact your local 4-H Purdue Extension educator for these additional requirements.*

1. **SEE GENERAL REQUIREMENTS FOR ALL SPECIES**
2. Identification (**ONE** of the following)
  - a. Physical description of the animal including: name, age, breed, color, gender, distinctive markings, cowlicks, scars, blemishes, biometric measures, brands, tattoos, etc.
  - b. Digital photographs sufficient to identify the individual animal
  - c. ISO-compliant electronic implant (microchip)
3. Testing
  - a. **Horses located within Indiana** do not need an equine infectious anemia (EIA, Coggins) test for exhibition in Indiana.
  - b. **Horses located outside of Indiana** must meet the following requirements prior to entering Indiana:
    - Each horse must test negative for EIA within 12 months of the date of exhibition. Each horse must be accompanied by an official certificate of veterinary inspection that indicates the date and results of the EIA test.

*NOTE: Suckling foals that are accompanied by their dam, when the dam has tested negative for EIA within the last twelve months, are exempt from the EIA testing requirement.*

### **E. Llamas/Alpacas (Camelids)**

1. **SEE GENERAL REQUIREMENTS FOR ALL SPECIES**
2. Identification (**ONE** of the following)
  - a. Physical description of the animal including: name, age, breed, color, gender, distinctive markings, cowlicks, scars, blemishes, biometric measures, etc.
  - b. Digital photographs sufficient to identify the individual animal
  - c. Official ear tag
  - d. Tattoo
  - e. ISO-compliant electronic implant (microchip)
3. Testing - No testing is required on any llamas or alpacas (camelid) for exhibition in Indiana.

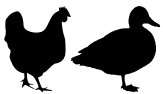

### F. Poultry

Indiana defines poultry as: chickens, turkeys, ostriches, emus, rheas, cassowaries, waterfowl (domesticated fowl that normally swim, such as ducks, geese and swans), and game birds (domesticated fowl such as pheasants, pea fowl, partridge, quail, grouse, and guineas) but **NOT** doves and pigeons.

1. **SEE GENERAL REQUIREMENTS FOR ALL SPECIES**
2. Identification - No individual identification is required on any poultry for exhibition in Indiana.
3. Testing

All poultry presented for exhibition, except waterfowl, must meet **ONE** of the following requirements:

- a. Test negative for pullorum-typhoid within 90 days prior to the date of the exhibition.
- b. Hatched from eggs that originate from a certified NPIP pullorum-typhoid clean parent flock.
- c. Originate from a flock that is certified NPIP pullorum-typhoid clean.

### G. Farm Raised Cervids

1. **SEE GENERAL REQUIREMENTS FOR ALL SPECIES**
2. Identification – Farm raised cervids must be identified with an **official ear tag** containing the US shield **AND** one of the following:
  - a. Tattoo
  - b. ISO-compliant electronic implant (microchip)
  - c. Farm/Management ear tag
3. Testing
  - a. **Farm raised cervids located within Indiana**, 12 months of age and older that are to be exhibited in Indiana must meet **ONE** of the following **tuberculosis** testing requirements:
    - Test negative for tuberculosis within 90 days prior to the date of the exhibition.
    - Originate from a herd that is accredited under a state tuberculosis accreditation program. 345 IAC 2.5-5-4.
    - From a herd that meets other herd testing standard described in 345 IAC 2.5-5-3(1).
  - b. **Farm raised cervids located within Indiana**, that are from a species known to be susceptible to chronic wasting disease (CWD), that are to be exhibited in Indiana must originate from a Certified CWD program herd defined under Indiana requirements 345 IAC 2-7-4.
  - c. **Farm raised cervids located outside of Indiana** must be from a CWD non-susceptible species (i.e. fallow deer) **AND** meet one of the following requirements as outlined in 345 IAC 1-3-29:
    - Originate from a tuberculosis free accredited herd.
    - Have two tuberculosis tests, 90 days apart, with the last test within 90 days of entry to Indiana.

***INSPECTION AND REGISTRATION WILL BE AT NORTH END OF ARENA, LOCATED IN THE PITS, UNTIL 1 HOUR BEFORE SCHEDULED START OF EVENT. INSPECTION STARTS AT 10:00 A.M. UNTIL 6:00 P.M. (NO LATE REGISTRATION OR INSPECTION). PARKING FOR PARTICIPATES WILL ENTER GATE 1 OF THE FAIRGROUNDS.***

**PARTICIPATION REGULATIONS**

1. The Monroe County Demolition Derby is promoted as an unusual spectator attraction. In the interest of safety and the promotion of family values events, anyone entering as a participant or spectator must obey ALL rules and regulations.
2. Inspection of cars starts at 10:00 am and the cars must be on the fairgrounds and through inspection by 6:00 pm. Drivers meeting at 6:30pm. This will be enforced and nonnegotiable.
3. Each driver must fill out an official entry and sign a liability release form before entering the pits for inspection. All drivers must supply their own cars. Only one entry per person per class. Men and women will run in same class. (No powderpuff)
3. **Drivers DO NOT have to have a valid driver's license.** Drivers less than 18 years of age must have a notarized release signed by legal parent/guardian.
4. **The Monroe County Demolition Derby Committee or their appointed representatives, reserve the right to approve or reject any entries, or vehicle.**

5. Each entry fee is \$40.00 and nonrefundable, even if your car does not pass inspection. Entry fee also includes one pit pass for driver.

**6. ONLY the cars and registered driver** can bring the car to inspection and must always remain in car at all times. No additional persons allowed (**drivers and officials only**) in the inspection area while inspections are underway. Mechanics can only enter after inspection is closed.

7. All drivers must attend the drivers meeting before the show starts.

8. You are responsible for your own safety. Building your cars to these rules alone, does not make demolition derbies safe. **These rules are to allow every car to have a fair chance to win.** You enter this demolition derby, (as in all motorsports) at your own risk, with the understanding that there is always a possibility of harm, injury, or death.

9. No cars permitted on track before their assigned event. Succeeding heat is to be lined up outside fenced area while preceding heat is on the track.

10. Cars may be re-inspected at any time and/or as many times as **The Monroe County Demolition Derby Committee** decides if necessary. Heat, consi, and top 4 feature winners will be re-inspected.

11. **The Monroe County Demolition Derby Committee** reserves the right to assign heats.

12. **The Monroe County Fairgrounds is a NO ALCOHOL property.** Anyone in possession of alcoholic beverages shall be removed from the Fairgrounds, with no refund of entry fees.

13. Officials and tech inspectors have final decision in all rules. If your car is flagged after inspection, your car is still open to inspection any time before, during, or after the derby.

14. Just because it is not listed in these rules, doesn't make it legal! **Anything determined to be unsafe, reinforcement, or creates an unfair advantage WILL be considered illegal.**

15. **All participants will operate their vehicles in a safe manner outside the arena! You will not operate vehicle over the speed of a fast walk in the pit area or anywhere on the fairgrounds, other than inside the perimeter of the derby arena. We have families moving from the parking area to the grandstands along with many volunteers and staff moving throughout all areas outside the arena. This will be strictly enforced!**

16. Helmets stay on the entire time in car. Only get out of car if told ok to do so. Drivers must make an aggressive hit every 60 seconds.

**RULES AND REGULATIONS No trucks, vans, ambulances, jeeps, carry all, limousines, hearse, 4wheel drives, checker cabs, propane cars, 73 or older Chrysler imperials. No Chrysler bodies on imperial frames. There is no mix matching of frames. Any American made or foreign-made two-wheel-drive car (front or rear wheel drive) will be allowed.**

**NO AMERICAN FLAGS ON THE TRACK DURING COMPETITION DUE TO POSSIBILITY OF FLAG FALLING OF CAR AND HITTING THE GROUND!**

**ANY ADDITIONAL WELDING WILL FORFEIT YOUR CAR FROM THIS CLASS BESIDES WHAT IS STATED IN THE RULES.**

## **RULES:**

1. Safety belts, approved helmets, goggles or face shields are mandatory. Approved safety glasses are also allowed.

2. All glass, trim moldings **and plastic bumper covers must be removed**, must be removed before entering the fairgrounds. Auto must be swept clean of all debris and loose parts. No mirrors are allowed. (Dash is not required to be removed)

**3. Engine & Transmission** Any engine / transmission may be used but must be mounted in a stock position. **Engine may have a lower cradle only!!! No other protectors!!!!!! (No DP, No Oil Pan, No Carb. Halo, No Pulley Protectors, No Transmission brace). IF OTHER PROTECTORS ARE ON ENGINE, YOU WILL BE DISQUALIFIED!** On a V block engine, the front spark plug must be even with or in front of the upper ball joint. On in-line engines, the number 2 spark plug must be even with or in front of the upper ball joint. Engine must be mounted with factory mounts. You may weld mounts with no metal added. Transmission must have factory rubber mount; Cross members must be stock or a single piece of angle iron and bolted in. Not welded.

4. ORIGINAL GAS TANKS MUST BE REMOVED. Original gas tanks may be relocated in back seat area or approved gas tank, such as marine type, is to be mounted in back seat area with secure metal fasteners. Must have # 9 wire or metal strapping around factory tank to floorboard. Tank can be mounted inside a halo no wider than 24" and 6" away from package tray area. Halo may only be attached to the rear cage bar. No gussets of any kind. ALL LINES MUST HAVE LEAKPROOF CONNECTIONS (such as fittings or clamps). Taped connections are not allowed. Gasoline approved rubber lines allowed, if new or of good quality. Otherwise, metal lines with 12 inches maximum rubber hose connections. Electric fuel pumps are allowed but must have a shut off switch mounted to the dash, three gallons of fuel max. All carburetors must have cover to suppress backfire flames.

**5. Body:** You can prebend rear body to help start the rear to go up, **CREASING FRONT FENDERS AND REAR QUARTERS IS OK.** NO tucking the trunk or quarter panels. Driver's door recommended to be plated with a minimum of 1/4" plate steel not to extend more than six inches past door seams. Plate must be attached with at least 4 bolts. **Doors may be wired shut with 9 wire, or chain in 3 locations per seam. OR NOT BOTH!!!! 2 3"x3" plates welded per seam on the vertical seams (NOT TOP OR BOTTOM SEAM).** Trailer hitch assemblies must be completely removed. Fire walls must remain intact with holes patched with thin sheet metal. Wheel wells may be cut to allow for tire clearance but NO bolting or welding. **Cannot weld washers to body to run #9 wire through.**

**6. Body Seams** cannot be screwed, bolted together.

**7. Frame** body bolts and mounts must be factory! The core support is the only mount that can be changed, Factory rubber mounts or use a single hockey puck with no larger than 7/16 bolt that may only be in the factory location. (This is so you can remove core support to swap engine). All other mounts must remain factory. Additional body mounts may **NOT** be added anywhere. Shorting the frames on Mercury's and Lincoln's 1" in front of Core support. Anything cutoff the frame cannot be added back. **2 4"X 6" frame patches are allowed for repair.**

**8. Bumpers** OEM bumpers or a 4x4x1/4 max bumpers are permitted. Ends must remain open, no metal added to bumper permitted and no points on 4x4x1/4 bumpers permitted. Any welds add to the bumpers will disqualify it.

**BOLTING BUMPER ON** mounting bumper nothing can go back 2" past the front face of frame, A 6X8 plate on the end of the frame rail can be added nothing else **OR 2"x2" angle** on 2 sides of the frame rail for mounting bumper. Bumper must still be Bolted to mounts. Bumpers must be bolted on with no bigger than 1/2 inch bolts or all thread. **4 bolts each side max.**

**OR NOT BOTH!!!!**

## WELDING BUMPER ON

MAY WELD BUMPER TO FRAME OR UNIBODY WITH ONE VERTICAL WELD PER SIDE. (ONE WELD ON DRIVER SIDE, ONE WELD ON PASSNGER SIDE) NO METAL ADDED, NO GUSSETS, NO BRACES, BUMPER TO FRAME ONLY. IF BUMPER IS BOLTED ON THIS IS NOT AN OPTION!!!!!!

Bumpers may not exceed 22" from the ground to the bottom of the bumper. **If running Factory Bumper shocks and factory mounting. You may weld ½ way around the bumper shock (if adding a plate or angle for bumper mounting this is not allowed)**

**9. Rearend: Must be stock appearing!** Any stock rearend, 5 lug max. Factory suspension to rearend. No braces, gussets, added steel to rearend housing. You may weld your rearend gears. NO slider drive shaft or custom shafts will be allowed.

**10. Radiators** must remain in stock positions and mounts (tilting allowed). **No spray foam mounting of any component.** No part of any cooling system allowed behind fire wall.

**11. Hood** must remain operable for initial inspection. Car must have hood at all times. HOODS MUST HAVE TWO 12"x12" HOLES CUT ON EACH OF CARBURETOR FOR FIRE CREW ACCESS. Hoods are allowed a maximum of six hold downs each using #9 wire or chain. Maximum of six strands of #9 or one wrap of chain. 2 locations allowed from core support to front bumper.

**11a. Trunk lids** must have a 12inch x 12 inch hole, are allowed a maximum of six hold downs each using #9 wire/chain. **OR NOT BOTH!!!! Have 2 3"x3" plates welded on the side seams of the trunk.** Trunk lids can be bent 90 degrees into the trunk, the part of the trunk lid in the trunk cannot be attached to anything. Maximum of six strands of #9 or one wrap of chain in 2 locations allowed from body to rear bumper. **BUT MUST NOT ATTACH TO TAILGATES/TRUNK LIDS.**

**12. Suspension** and steering components (minus steering column) **MUST** be OEM to that vehicle. No Swapping spindles or arms from other years. Suspension must remain free with a minimum of 4" free travel. **You may kick front springs**, spring jacks, blocked shocks, wedging, reversing shackles not allowed. Air shocks must have air lines cut. Shocks and suspension must **NOT** be altered in any way. **NO** increasing the height of vehicle from its factory height. Bumpers minimum height 14", maximum height is 22" from ground to bottom of bumper.

**13. Batteries** must be relocated to front passenger area with **SECURE** mounts and non-flammable cover. Bungee or tarp straps are not allowed.

**14.** Cars must have **brakes** each and every time the car enters the track.

**15. Floating cage: SEAT BAR IS REQUIRED! Everything else is optional.** Optional 4-point floating cage. Cage bars can be up to 4" x 4" square tube, Side bars only can be 2" x 6" as an option. You may have one 2"x2" bar per side located in the middle of the front doors that run vertical. No other down legs or kickers of any kind. Roll over bar can be up and over but not attached in any way. Roll over bar cannot be bolted or welded to roof. 60" max door bar length, Rear seat bar must be 4" in front of rear seat bottom. You can weld cage to door post and steering column to secure cage. Side bars must be bolted through doors in 2 places.

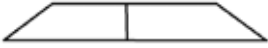
**16. Any exhaust pipes** penetrating the hood must point upwards, not toward front, sides, or driver.

**17. No white cars allowed.** Driver's door **ONLY**, **MUST** be white. Cars must have **BOLD 18"** numbers on each side of car and **Mandatory Roof sign with BOLD 18" numbers**. No obscenities allowed on car.

**18. Tires.** Any tire that holds air can be used (does not have to be DOT tire). Tires may be filled. **Only small weld in centers, no reinforced beads or bead locks.** Fenders may be trimmed for tire clearance. **No bolting fenders.**



19. All cars must have a vertical safety bar in windshield area (to keep hood from entering driver's area).



20. May run aftermarket gas/brake pedal, steering column, shifter, headers, and fuel cell. Nothing can reinforce the car in any way.

21. All decisions by officials shall be final. **NO APPEALS!**

22. Only drivers participating on the track are allowed to remain on track at conclusion of that heat, consi, or feature.

23. **Cutting torches or welders** in pit area must have fire suppression of some type, e.g. fire extinguisher, pressurized water, sand, etc.

24. Do not read between the lines or look for gray areas in these rules. These rules tell you what you can do and everything else is illegal. **IF IT IS NOT CLEARLY ADDRESSED IN THESE RULES, IT IS NOT ALLOWED!**

## DISQUALIFICATIONS

- A. Intentionally hitting an opponent's driver's door.
- B. Blatant team driving will result in all those avoiding hits or holding cars while others are hitting, will result in disqualification. This will be a judgment call by officials and all rulings of officials shall be final.
- C. Intentionally hitting a car stuck on logs or on dirt boundary. This is considered a serious matter for the safety of the crowd and volunteers.
- D. Winners of heats and consi must be re-inspected at east end of arena before going to pits, if you do not stop for re-inspection before exiting the arena, you will be disqualified.
- E. Intentionally pushing another car out of arena through entrance or exit or holding them from re-entering.
- F. **Disobeying, arguing, or use of profanity to any official or volunteer may constitute dismissal for the entire event and grounds for expulsion from the Fairgrounds and consideration for permanent barring from further competitions at the Monroe County Fairgrounds.**
- G. Spilling fuel or catching fire (exhaust fire or carburetor fire that is immediately withdrawn on its own excluded).
- H. Flagmen may disqualify any vehicle, which in his/her opinion constitutes a reasonable safety hazard to the driver, other competitors, or spectators.
- I. The derby will be composed one feature demolition event will be comprised of winners and placings of top 3 of each heat. This is liable to change based on car count. This will be decided during the drivers meeting.

Driver's door recommended to be plated with a minimum of 1/4" plate steel not to extend more than six inches past door seams. Plate must be attached with at least 4 bolts. **Doors may be wired shut with 9 wire, or chain in three locations per seam. OR NOT BOTH!!!! 2 3"x3" plates welded per seam on the vertical seams (NOT TOP OR BOTTOM SEAM).** Trailer hitch assemblies must be completely removed. Fire walls must remain intact with holes patched with thin sheet metal.

7. **Bumpers** must be a OEM. No 1980 or older full-size bumpers. Must be same width as the tires. **Any Welds add to the bumper will disqualify it.**

### **BOLTING BUMPER ON**

mounting bumper nothing can go back 2" past the front face of frame, A **6X8** plate on the end of the frame rail can be added nothing else **OR** 2"x2" angle on 2 sides of the frame rail for mounting bumper. Bumper must still be Bolted to mounts. Bumpers must be bolted on with no bigger than ½ inch bolts or all thread. 4 bolts each side max.

Roll over bar cannot be bolted or welded to roof. 60" max door bar length, Rear seat bar must be 4" in front of rear seat bottom. You can weld cage to door post and steering column to secure cage. Side bars must be bolted through doors in 2 places.
15. **Any exhaust pipes** penetrating the hood must point upwards, not toward front, sides, or driver.
16. **No white cars allowed.** Driver's door ONLY, **MUST** be white. Cars must have BOLD 18" numbers on each side of car and **Mandatory Roof sign with BOLD 18" numbers.** No obscenities allowed on car.
17. **D.O.T. type tires only.** Rims may have small weld in centers, NO bead protectors. Fenders may be trimmed for tire clearance. **No bolting fenders.**
18. Must use Factory Steering column. Aftermarket shifters ok.
19. All cars must have a vertical safety bar in windshield area (to keep hood from entering driver's area).
20. All decisions by officials shall be final. **NO APPEALS!**
21. Only drivers participating on the track can remain on track at conclusion of that heat, consi, or feature.
22. **Cutting torches or welders** in pit area must have fire suppression of some type, e.g. fire extinguisher, pressurized water, sand, etc.

Building your cars to these rules alone, does not make demolition derbies safe. **These rules are to allow every car to have a fair chance to win.** You enter this demolition derby, (as in all motorsports) at your own risk, with the understanding that there is always a possibility of harm, injury, or death.

9. No cars permitted on track before their assigned event. Succeeding heat is to be lined up outside fenced area while preceding heat is on the track.

10. Cars may be re-inspected at any time and/or as many times as **The Monroe County Demolition Derby Committee** decides if necessary. Heat, consi, and top 4 feature winners will be re-inspected.

11. **The Monroe County Demolition Derby Committee** reserves the right to assign heats.

12. **The Monroe County Fairgrounds is a NO ALCOHOL property.** Anyone in possession of alcoholic beverages shall be removed from the Fairgrounds, with no refund of entry fees.

13. Officials and tech inspectors have final decision in all rules. If your car is flagged after inspection, your car is still open to inspection any time before, during, or after the derby.

14. Just because it is not listed in these rules, doesn't make it legal! **Anything determined to be unsafe, reinforcement, or creates an unfair advantage WILL be considered illegal.**

15. **All participants will operate their vehicles in a safe manner outside the arena! You will not operate vehicle over the speed of a fast walk in the pit area or anywhere on the fairgrounds, other than inside the perimeter of the derby arena. We have families moving from the parking area to the grandstands along with many volunteers and staff moving throughout all areas outside the arena. This will be strictly enforced!**

16. Helmets stay on the entire time in car. Only get out of car if told ok to do so. Drivers must make an aggressive hit every 60 seconds.

**RULES AND REGULATIONS** No trucks, vans, ambulances, jeeps, carry all, limousines, hearse, 4wheel drives, checker cabs, propane cars, 73 or older Chrysler imperials. No Chrysler bodies on imperial frames. There is to be no mix matching of frames or motor and transmission. Ford/Ford. GM/GM. Dodge/Dodge. Any American made or foreign-made two-wheel-drive car (front or rear wheel drive) will be allowed.

**NO AMERICAN FLAGS ON THE TRACK DURING COMPETITION DUE TO POSSIBILITY OF FLAG FALLING OF CAR AND HITTING THE GROUND!**

**ANY ADDITIONAL WELDING WILL FORFEIT YOUR CAR FROM THIS CLASS BESIDES WHAT IS STATED IN THE RULES.**

## RULES:

1. Safety belts, approved helmets, goggles, or face shields are mandatory. Approved safety glasses are also allowed.
2. All glass, trim moldings **and plastic bumper covers must be removed** must be removed before entering the fairgrounds. Auto must be swept clean of all debris and loose parts. No mirrors are allowed. (Dash is not required to be removed)
3. **Engine & Transmission** stock sized motors only. Drive train must be GM/GM or Ford/Ford, Dodge/Dodge, etc.
4. ORIGINAL GAS TANKS MUST BE REMOVED. Original gas tanks may be relocated in back seat area or approved gas tank, such as marine type, is to be mounted in back seat area with secure metal fasteners. Must have # 9 wire or metal strapping around factory tank to floorboard. ALL LINES MUST HAVE LEAKPROOF CONNECTIONS (such as fittings or clamps). Taped connections are not allowed. Gasoline approved rubber lines allowed, if new or of good quality. Otherwise, metal lines with 12 inches maximum rubber hose connections. Electric fuel pumps are allowed but must have a shut off switch mounted to the dash, three gallons of fuel max. All carburetors must have cover to suppress backfire flames.
5. **Body:** You can pre-bend rear body to help start the rear to go up, **CREASING FRONT FENDERS AND REAR QUARTERS IS OK**. NO tucking the trunk or quarter panels. Driver's door may be plated with a minimum of 1/4" plate steel not to extend more than six inches past door seams. Plate must be attached with at least 4 bolts. **Doors may be wired shut with 9 wire, or chain in three locations per seam. OR NOT BOTH!!!! 2 3"x3" plates welded per seam on the vertical seams (NOT TOP OR BOTTOM SEAM)**. Trailer hitch assemblies must be completely removed. Fire walls must remain intact with holes patched with thin sheet metal. Wheel wells may be cut to allow for tire clearance but NO bolting or welding. **Cannot weld washers to body to run #9 wire threw.**
6. **Body Seams** cannot be screwed, bolted together

**7. Frame** is to remain stock (O.E.M) and remain in stock mounts and locations. If mount is missing, 2 strands of #9 wire can be around body to frame in the mount location. Any replacements will change the class of cars you run in or disqualify from running. Additional body mounts may **NOT** be added anywhere. Shorting the frames on Mercury's and Lincoln's 1" in front of Core support. Anything cutoff the frame cannot be added back. **NO frame patches NO WELDING ALLOWED!**

**8. Bumpers** OEM bumpers, Any Welds add to the bumpers will disqualify it.

**BOLTING BUMPER ON** mounting bumper nothing can go back 2" past the front face of frame, A **6x8** plate on the end of the frame rail can be added nothing else **OR** 2"x2" angle on 2 sides of the frame rail for mounting bumper. Bumper must still be Bolted to mounts. Bumpers must be bolted on with no bigger than ½ inch bolts or all thread. 4 bolts each side max.

**OR NOT BOTH!!!!**

**WELDING BUMPER ON**

**MAY WELD BUMPER TO FRAME OR UNIBODY WITH ONE VERTICAL WELD PER SIDE. (ONE WELD ON DRIVER SIDE, ONE WELD ON PASSNGER SIDE) NO METAL ADDED, NO GUSSESTS, NO BRACES, BUMPER TO FRAME ONLY. IF BUMPER IS BOLTED ON THIS IS NOT AN OPTION!!!!**

Bumpers may not exceed 22" from the ground to the bottom of the bumper.

**If running Factory Bumper shocks and factory mounting. You may weld ½ way around the bumper shock (if adding a plate or angle for bumper mounting this is not allowed)**

**9. Rearend** stock rear ends ONLY. NO gear changes. You may weld your rear end gears. You MUST have a stock rear end that bolts directly in. No welding mounting ears to use a different rearend. NO slider drive shaft or custom shafts will be allowed **This is the only welding allowed (and it is optional).**

**10. Radiators** must remain in stock positions and mounts (tilting allowed). **No spray foam mounting of any component.** No part of any cooling system allowed behind fire wall.

**11. Hood** must remain operable for initial inspection. Car must have hood at all times. HOODS MUST HAVE TWO 12"x12" HOLES CUT ON EACH OF CARBURETOR FOR FIRE CREW ACCESS. Hoods are allowed a maximum of six hold downs each using #9 wire or chain. Maximum of six strands of #9 or one wrap of chain. 2 locations allowed from core support to front bumper.

**11a. Trunk lids** must have a 12inch x 12-inch hole, are allowed a maximum of six hold downs each using #9 wire/chain. **OR NOT BOTH!!!! Have 2 3"x3" plates welded on the side seams of the trunk.** Trunk lids can be bent 90 Degree into the trunk, the part of the trunk lid in the trunk cannot be attached to anything. Maximum of six strands of #9 or one wrap of chain in 2 locations allowed from body to rear bumper. BUT MUST NOT ATTACH TO TAILGATES/TRUNK LIDS.

**12. Suspension** and steering MUST be OEM to that vehicle. No Swapping spindles or arms from other years. OEM rear end and drive line only. Suspension must remain free with a minimum of 4" free travel. **NO KICKING FRONT SPRINGS,** spring jacks, blocked shocks, wedging, reversing shackles not allowed. Air shocks must have air lines cut. Shocks and suspension must NOT be altered in any way. NO increasing the height of vehicle from its factory height. Bumpers minimum height 14", maximum height is 22" from ground to bottom of bumper.

**13. Batteries** must be relocated to front passenger area with **SECURE** mounts and non-flammable cover. Bungee or tarp straps are not allowed.

**14.** Cars must have **brakes** each and every time the car enters the track.

**15. Floating cage: SEAT BAR IS REQUIRED! Everything else is optional.** Optional 4-point floating cage. Cage bars can be up to 4" x 4" square tube, Side bars only

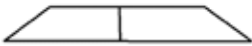
can be 2" x 6" as an option. No down legs or kickers of any kind. Roll over bar -can be up and over but must not be attached in any way. Roll over bar cannot be bolted or welded to roof. 60" max door bar length, Rear seat bar must be 4" in front of rear seat bottom. You can weld cage to door post and steering column to secure cage. Side bars must be bolted through doors in 2 places.

**16. Any exhaust pipes** penetrating the hood must point upwards, not toward front, sides, or driver.

**17. No white cars allowed.** Driver's door ONLY, **MUST** be white. Cars must have BOLD 18" numbers on each side of car and **Mandatory Roof sign with BOLD 18" numbers.** No obscenities allowed on car.

**18. D.O.T. type tires only must be stock appearing, no exceptions.** Rims may have small weld in centers, NO bead protectors. Fenders may be trimmed for tire clearance. **No bolting fenders.**

**19.** All cars must have a vertical safety bar in windshield area (to keep hood from entering driver's area).



**20.** Must use Factory Steering column. After market shifters ok.

**21.** All decisions by officials shall be final. **NO APPEALS!**

**22.** Only drivers participating on the track are allowed to remain on track at conclusion of that heat, consi, or feature.

**23. Cutting torches or welders** in pit area must have fire suppression of some type, example: fire extinguisher, pressurized water, sand, etc.

**24.** Do not read between the lines or look for gray areas in these rules. These rules tell you what you can do and everything else is illegal. **IF IT IS NOT CLEARLY ADDRESSED IN THESE RULES, IT IS NOT ALLOWED!**

### **DISQUALIFICATIONS**

- A. Intentionally hitting an opponent's driver's door.
- B. Blatant team driving will result in all those avoiding hits or holding cars while others are hitting, will result in disqualification. This will be a judgment call by officials and all rulings of officials shall be final.
- C. Intentionally hitting a car stuck on logs or on dirt boundary. This is considered a serious matter for the safety of the crowd and volunteers.
- D. Winners of heats and consi must be re-inspected at east end of arena before going to pits, if you do not stop for re-inspection before exiting the arena, you will be disqualified.
- E. Intentionally pushing another car out of arena through entrance or exit or holding them from re-entering.
- F. **Disobeying, arguing, or use of profanity to any official or volunteer may constitute dismissal for the entire event and grounds for expulsion from the Fairgrounds and consideration for permanent barring from further competitions at the Monroe County Fairgrounds.**
- G. Spilling fuel or catching fire (exhaust fire or carburetor fire that is immediately withdrawn on its own excluded).
- H. Flagmen may disqualify any vehicle, which in his/her opinion constitutes a reasonable safety hazard to the driver, other competitors, or spectators.
- I. The derby will be composed one feature demolition event will be comprised of winners and placings of top 3 of each heat. This is liable to change based on car count. This will be decided during the drivers meeting.

### Rules/Regulations:

- Sign-up one half hour before pull time.
- Children must weigh in at time of entry.
- Weight classes will be:
  - Class A 30lbs. to under 40 lbs.
  - Class B 40 lbs. to under 50 lbs.
  - Class C 50 lbs. to under 60 lbs.
  - Class D 60 lbs. to under 75 lbs.
- One pull per child
- Parental written permission is mandatory
- Child must be present at time of call or disqualified
- Children must wear shoes
- Children must not touch wheels while pulling
- Children must stay within pulling boundaries when pulling. At any time tractor leaves boundaries, child is stopped and measurements are taken.
- Children may enter each day, but can only win to be eligible for the championship one time.
- Class weight will be measured with the scales at time of check in each day.
- There will be a pull off in each class for all children who make a full pull.
- Each child pull will receive a participation ribbon.
- Decisions of officials will be final.

## OPEN CLASS EXHIBITS

### GENERAL RULES

1. Anyone in Monroe County is eligible to exhibit. Exhibitor must reside in Monroe County **OR** be a current member of a Monroe County Extension Homemakers Club/Monroe County Master Gardeners.
2. Items entered must have been finished since the last fair, except quilts. **ALL ITEMS MUST BE MADE OR GROWN BY THE EXHIBITOR.** You may not enter an item that has won a ribbon or prize money at a previous Monroe County Fair.
3. Only one exhibit may be shown by an individual in any one entry number.
4. All exhibits must either meet the 2' by 3' space limit or other limits determined by the individual superintendents.
5. Any soiled or damaged item or items not meeting requirements will NOT be judged and will be given an exhibitor ribbon.
6. All perishable exhibits will be disposed of due to food safety/sanitation guidelines at the discretion of the Department Superintendent.
7. **Sign-in Procedure:** Register at computer with name-and number of exhibits **EACH time projects are entered.**

### ENTRIES:

1. Note that entries are delivered to the fairgrounds during different times depending on their category. Since entries can only be accepted at the indicated times, be sure to note in which category your items belong.
2. Exhibits entered by **daycares, preschools, and nursing homes** MUST be delivered on **Tuesday, June 27, 2023** from **1:00pm to 3:00pm ONLY.**
3. Most other items, with exceptions listed below, MUST be delivered on **Wednesday, June 28, 2023** between **3:00pm and 7:00pm.**
4. **ALL foods/baked goods, including children's foods,** must be delivered on **Monday, July 3, 2023** between **9:00am and 11:00am.**
5. **Vegetables, Herbs, Fruits, Seeds** must be delivered between **1:00pm and 3:00pm** on **Saturday, July 1, 2023.**
6. **Potted Plants, Cut Flowers and Floral Design** must be delivered between **9:00am and 11:30am** on **Monday, July 3, 2023.**

### JUDGING:

1. All articles (except foods, vegetables, herbs & seeds, plants, floral design, and cut flowers) will be judged at **9:00am on Thursday, June 29, 2023.** Judging is CLOSED to the public. ONLY members in charge of the entries may be present to assist the judges. **The Community Building will be open to the public at 10:00 am on Monday, July 3, 2023.**
2. Foods/baked goods, fresh produce, plants, floral design, fresh flowers, seed-grains, saved seeds, and **Bake-It with Chocolate** are judged right after they have been entered. See times above.

### RELEASE OF ENTRIES:

1. All exhibits are released on **Sunday, July 9 from 1:00pm - 3:00pm.** Pick up premium money at the same time. If unable to pick up, please call

the Extension Office at 812-349-2575 to make arrangements. After **August 31, 2023**, premium money will be returned to the Fair Board and remaining exhibits will be recycled.

#### **MISCELLANEOUS:**

1. Entry tags may be picked up after **June 1, 2023** at the **Purdue Extension-Monroe County Office located at 3400 South Walnut Street, Bloomington, IN 47401**. Filling out the entry tags before bringing the items to the fair will speed things up at entry time.
2. For sale signs or business cards are prohibited when displaying exhibits. Exhibits are not for sale.
3. The Monroe County Fair Board or its committees are not responsible for loss, damage, or breakage of any article on exhibit.
4. **Indiana State Fair Exhibitors:** Call the Purdue Extension-Monroe County Office at 812-349-2575 between **June 1** and **July 1, 2023** for application information and state fair forms to exhibit at the State Fair. All State Fair entries must be registered by **July 1, 2023**. Please see the Indiana State Fair website for further information.

#### **AWARDS**

1. Each entry will be given a ribbon placement of first (blue), second (red) or third (white), if merited by judge.
2. Honor ribbons (purple) will be chosen from first place entries, if merited by judge.
3. One Champion and/or One Reserve Champion ribbon can be chosen in each **CLASS**, if merited by judge.
4. One Grand Champion and/or one Reserve Grand Champion will be chosen in each **DIVISION**, if merited by judge.
5. Exhibitor will **only** receive the highest ribbon awarded by the judge.
6. Cash awards will be given on the highest ribbon earned for each adult entry: \$1.00 (first place), \$0.50 (second place) and \$0.25 (third place)
7. Ribbons will be given to each child exhibiting in the Children's class with cash awards of \$0.50 per project.

### **GUIDELINES:**

1. Exhibit must be a baked or cooked product. The featured ingredient, **Caramel**, must be baked or cooked into the product. All items must be made from scratch. Store bought pie crusts, mixes (cake, muffin, biscuit, etc.) **ARE NOT PERMITTED.**
2. Commercial jams, jellies, and juice are permitted. **Yogurt is not permitted in any entry.**
3. Perishable or potentially unsafe food products ARE NOT PERMITTED. See PURDUE EXTENSION FOOD SAFETY POLICY (below).
4. One full-sized, uncut product required, EXCEPT items such as cookies, muffins, candy, doughnuts, etc. (3 items on a plate)

5. A complete recipe (include your full name) MUST accompany each product and becomes the property of MCEHA.
6. Exhibitor must be a permanent Monroe County resident, age 10 or older or a member of MCEHA.
7. All items must be made, entered and exhibited in the baker's name.
8. Only one entry per category for each individual exhibitor.
9. Only a portion will be kept for exhibit. **NOTE:** For Grand and Reserve Grand Champions, the entire product is kept on display.
10. **Food may be picked up** after judging until **6:00 pm** that evening. After 6:00 pm, all food will be discarded.
11. For each entry, please include name, address and telephone number on an entry tag (available at the registration table the day of the Bake-It Contest). Entry tags are also available earlier in the week in the Community Building.

**Please label all non- disposable containers and dishes with name AND contact information!**

**PURDUE EXTENSION FOOD SAFETY POLICY (revised 10/20/20)**

**For Food Competitions:** Fillings, frostings, glazes, and meringues are not permitted to contain cream cheese, sour cream, heavy cream, or whipped cream if they are not fully cooked/baked. These items are allowed as ingredients in food products IF the final product is cooked/baked. Additionally, raw milk, raw milk products or uncooked eggs/egg whites are not permitted. Eggs/egg whites that have been cooked to 160 F (i.e. pasteurized or included as part of a batter and baked) are acceptable. No home- canned fruits, vegetables, or meats are permitted as ingredients in food products.

Fresh-cut, uncooked, fruits and/or vegetables are not permitted to be used in food products or used in food products or used as garnishes for the product Foods should be transported to the competition in a way that minimizes contamination and maintains the quality of the food (i.e. foods that are judged as frozen should remain frozen at all times).

Recipes must be provided that identifies all ingredients that were used in each part of the product. Any ingredient that could be a potential allergen must be clearly identified. Each food product must be labeled with the following information:

- Name
- Address
- Contact information (phone and/or email address)
- Date the food product was made

Contestants should carefully wash their hands and make sure that their hands do not have any open cuts before preparing foods. If cuts are present, the wound should be bandaged and a single use food service glove worn on the hand during all stages of food production. Contestants should not be preparing food exhibits for competition within 48 hours of recovering from any illness. People experiencing symptoms of vomiting, diarrhea, fever, and/or jaundice should not be allowed to prepare food

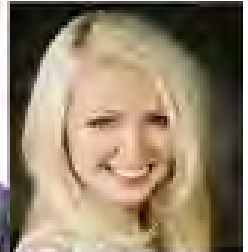

1. Arrangements must be entered between **9:00am** and **11:30am** on **Monday, July 3**.
2. Judging will begin at 1:00pm. Exhibits space opened to the public by 5:00pm.
3. Competition is open to **ANY** resident of Monroe County or member of Monroe County Extension Homemakers or Master Gardener Association.
4. Only one entry in each numbered item is allowed per exhibitor. However, exhibitors are encouraged to enter as many numbered items as desired.
5. Entries must be arranged by exhibitor.
6. Flowers and foliage may be either grown or purchased by the exhibitor.
7. All arrangements must include at least six main blooms and two kinds of greenery unless stated otherwise in the item descriptions. Foliage on the flowers themselves does not count as greenery. More than six blooms may be used and is encouraged in most arrangements.
8. Only fresh materials may be used in arrangements. **NO ARTIFICIAL FLOWERS ARE PERMITTED.** Dried materials and accessories may be used sparingly. Containers and accessories are of secondary importance and must complement and blend with the overall composition.
9. Containers must be waterproof and have a reservoir large enough to hold water. Baskets must have a rigid plastic liner. Plastic bags, very shallow containers and foam placed directly into baskets are not permitted.
10. Floral foams and other mechanical aids are permitted but should not be visible.
11. Flowers, containers and accessories are the responsibility of the owner and should be clearly marked with the owner's name on the bottom. The Fair Board and the Floral Design Show committee assume no responsibility.
12. All entries must be removed from the exhibit space between **1:00 and 3:00 pm** on **Sunday, July 9**. Premium money must also be claimed at that time.
13. Judges may award Grand and Reserve Grand Champion to the arrangements judged best from all first-place arrangements in both Open and Children's Divisions (*see awards information under general rules*).

## THE JUDGE WILL LOOK FOR:

1. Six main blooms and two types of greenery
2. Freshness and quality of flowers and greenery
3. Expression of the theme
4. Overall pleasantness, balance, proportion, color and texture

## TIPS FOR PROCESSING FLOWERS TO HELP THEM LAST LONGER AFTER CUTTING

1. Cut early in the morning the day **BEFORE** using.
2. Recut the stems and place in **WARM** water with floral preservative if available. Water should be warm enough for you to sit in comfortably.
3. Leave the flowers in the warm water for about two (2) hours at room temperature; place in refrigerator and leave **OVERNIGHT**.
4. **Remember that Daylilies last only 1 day. Do not process the day ahead**

No mixes allowed except in Fix Up a Mix category.

After entries are judged, a portion will be kept for exhibit and the remainder may be picked up Monday only, between 3:00 and 6:00pm. After 6:00pm, the food will be donated or discarded.

**Perishable or potentially unsafe food products ARE NOT PERMITTED.** See PURDUE EXTENSION FOOD SAFETY POLICY (below)

### PURDUE EXTENSION FOOD SAFETY POLICY (revised 10/20/20)

**For Food Competitions:** Fillings, frostings, glazes, and meringues are not permitted to contain cream cheese, sour cream, heavy cream, or whipped cream if they are not fully cooked/baked. These items are allowed as ingredients in food products IF the final product is cooked/baked. Additionally, raw milk, raw milk products or uncooked eggs/egg whites are not permitted. Eggs/egg whites that have been cooked to 160 F (i.e. pasteurized or included as part of a batter and baked) are acceptable. No home- canned fruits, vegetables, or meats are permitted as ingredients in food products.

Fresh-cut, uncooked, fruits and/or vegetables are not permitted to be used in food products or used in food products or used as garnishes for the product. Foods should be transported to the competition in a way that minimizes contamination and maintains the quality of the food (i.e. foods that are judged as frozen should remain frozen at all times).

Recipes must be provided that identifies all ingredients that were used in each part of the product. Any ingredient that could be a potential allergen must be clearly identified. Each food product must be labeled with the following information:

- Name
- Address
- Contact information (phone and/or email address)
- Date the food product was made

Contestants should carefully wash their hands and make sure that their hands do not have any open cuts before preparing foods. If cuts are present, the wound should be bandaged and a single use food service glove worn on the hand during all stages of food production. Contestants should not be preparing food exhibits for competition within 48 hours of recovering from any illness. People experiencing symptoms of vomiting, diarrhea, fever, and/or jaundice should not be allowed to prepare food

1. Entries must be made between **9:00am and 11:30am on Monday, July 3.** Judging will begin at 12:30pm. Entries/premiums may be picked up on **Sunday, July 9, between 1:00 and 3:00pm.** Entries must have been grown by the exhibitor in **Monroe County, IN** (see general rule #1 about who is eligible to exhibit).
2. Exhibitors may not have more than one potted plant or one vase per entry number.
3. Vases for the cut flowers must be of a shape and size suitable to hold the plants; they should not tip over easily. **Do not bring valuable containers.** Any type of vase will do and recycled jars and bottles are recommended. Containers for potted plants may not be larger than 20" in any dimension. Place your name on the bottom of containers and vases. Containers or vases will not be part of the judging. Exception is for the unusual container class.
4. Terms used in this section: specimen= the variety or cultivars of a species (for example, a specimen of zinnia is Z.elegans "large flowered"; the Z.elegans "Peter Pan" would be different zinnia specimen); 1 stem = a flower stalk bearing one or more flowers; 3 stems= three stalks of the same specimen and they must be of the same color.

### WHAT THE JUDGE IS LOOKING FOR

1. Blossoms and foliage that is healthy, free from insects and without weather damage. Flowers that are fully opened but not past their prime. Flowers should be pollen free. Petal color should be vibrant, not old or muddy.
2. For entries with 3 stems, flowers should be similar in size and uniform.
3. Stems should touch the bottom of the vase and be straight and sturdy.
4. Should have foliage (if applicable), but no foliage below water level

- Premiums will be awarded **only** to the highest ribbon earned as follows: Grand Champion (\$100), Reserve Grand Champ (\$80.00), Champion (\$50), Reserve Champion (\$35), Honor (\$15), and Blue (\$10).

#### CLASSES:

- Family Outfits:** Persons wearing garment(s) she/he has made, plus any other family member(s) wearing garments made for them
- Sewing for Others/Children's Garment, Infants to age 5:** Any type of child's garment. Seamstress must be present at the judging.
- Sewing for Others/Children's Garment, Ages 6-12:** Any type of child's garment. Seamstress must be present at the judging.
- Sewing for Others/Teen Garments, Teen ages 13-17:** Any type of teen's garment. Seamstress must be present at the judging.
- Sewing for Others/Adult over 18:** Any type of garment. Seamstress must be present at the judging.
- Dresses:** Street length dress, one or two piece, a dress with own jacket, coat or vest suitable for daytime wear. Also includes jumper and blouse.
- Coats and Suits:** Separate coat for your wardrobe, to be solely a coat with its own accessories. Suits being two or more pieces (i.e. Skirt or pants with jacket, cape, or vest of the same fabric, shown with or without its own blouse or shirt). Jacket, coat, cape or vest **MUST** be lined.
- Separates:** True coordinates. Must be 2 or more garments sewn by the seamstress and modeled together for a complete look. All garments must be worn. Each piece should be important enough to stand on its own or with other garments. Accessory items such as sweater, blouse or shirt may be a purchased garment.
- My Choice:** Active wear (i.e. Tennis wear/swimwear), western, loungewear or costumes (such as historic, dance, international or Halloween), or any other outfit not otherwise classified which do not fit in the above classes. **NO Bridal Gowns (see Class K).**
- Formal Gowns or Dresses: NO BRIDAL GOWNS (see Class K).**
- For Bridesmaid Gowns or formal family wear (one person modeling only). Seamstress must be present at the judging.
- Wedding Gowns, Bridesmaids, or Formals:** Seamstress of the garment must be present at the judging.

M. **Other, Embellished w/Hand or Machine Embroidery:** Any hand-made garment has been embellished by Hand or Machine Embroidery.
